

TERMS AND CONDITIONS

SHRUTI'S BEAUTY & BRIDAL SALON

Thank you for visiting about our Bridal & Party Makeup - Hair & Henna services. Please review our Terms and Condition Policy below. All terms & Conditions will apply with or without contract.

DEPOSIT(RETAINERS) :

A Non-refundable deposit of 40% of total order required to Secure and reserve your Event date & time. Deposit will secure the Party's Event or wedding date & Specific time block on our Scheduling calendar once deposit received.

Payment Method: Cash - venmo - zelle - CashApp

PAYMENT: The person responsible for the entire balance of the payment is the person who has agreed to the Terms & Conditions.

The final payment is due (2) week before the wedding or event date as one payment. If final payment is not received (2 or 1) week prior to the wedding or Event date, then services will be canceled. The person responsible for the balance of payment is either the Client who has signed the service contract or the person he/she has indicated on the booking agreement. No exceptions!

You will be fully charge for each final headcount for Hair or Makeup - if canceled due to late arrival - No time - late starting or any other reason.

PARKING FEES / TOLL CHARGE :

Where parking or valet fees or Toll charge may be incurred to provide you on location service, the amount will be included in the final bill and due for payment on the day of the event.

TRAVEL FEE: Travel fees incurred depending on the return distance of travel required. This amount specified in the quotation and is determined according to the location of event.

IMAGES OF WORK: The Artist may use the images of her performed work of Hairstyle - Makeup - Henna on its website and/or in any advertising media.

CANCELLATIONS:

- If the Client cancels any services after secure & reserve date. The deposit is non-refundable and non-transferable.
- If Cancellation done by Shruti's Bridal Salon at any time and unable to perform service for any reason, the deposit paid will be fully refunded.

LIABILITY & RESPONSIBILITY OF THE CLIENT :

- The client shall inform to Artist of any issues affect her from product, This includes but not limited to sensitivities, allergies and medical conditions. If the client has an allergic reaction., Shruti's Bridal salon can not be held responsible.
- Client(s) agree to release the Makeup artist and SHRUTI'S BRIDAL SALON from any liability not limited to any skin complications.

Additional cost and additional services to be paid on the Event day, if occurs:

- The initial hair styling charge indicated are a base price. Hairstyle charge may be increase due to the individual's length of hair, Thickness, and texture of hair or for special styling
- For Bridal Hairstyle : If Hair Bun, Hair extension will used for updo's OR Juda hairstyle , Or Curly hair Extension, client will pay refundable deposit for Hair bun or other hair accessory at the time of service and return back hair accessory within 2 - 5 days to get back full refund of deposit , by mail or by person. Otherwise, there is option of purchase it, for very minimal charge of \$12+for each Accessory.
- For Party Hair Style – client will have to pay for hair bun or other hair accessory wants to use.
- Hair Decoration – Hair Broach – Flowers to enhance hairstyle will be available for purchase of minimal charge of \$12+ (depends)
- For Party makeup: add on Fake Eyelash: \$15
